BioOne Rings in the New Year with New Content, Delivery Models

Happy New Year! BioOne is celebrating 2013 by welcoming five new titles that made their debut on the BioOne site on January 2. With these additions, BioOne now includes 176 critical publications from across the world. Please join us in welcoming:

- Applications in Plant Sciences, published by the Botanical Society of America (BioOne OA)
- Cryptogamie, Algologie, published by the Association des Amis des Cryptogames (BioOne.2)
- Cryptogamie, Bryologie, published by the Association des Amis des Cryptogames (BioOne.2)
- Cryptogamie, Mycologie, published by the Association des Amis des Cryptogames (BioOne.2)
- Marine Resource Economics, published by the Marine Resource Foundation, Inc.

In addition to this exciting new content, we would like to highlight the continuing contributions of BioOne's existing publishing partners, many of which are experimenting with new publishing models designed to expand content access and usage.

For instance, ten BioOne publications now utilize an "Issue-in-Progress", article-byarticle workflow on BioOne, which allows for the early publication of final articles before publication of the formal issue. This model benefits both authors—who enjoy a lengthened usage and citation window as well as end users—who receive early access to critical articles as part of their BioOne subscription. You can see this model at work by browsing through the following BioOne publications:

Note that the Issue-in-Progress folder will only appear if there are articles available with which to populate it, otherwise, the list of issues will appear unchanged.

New titles Applications in Plant Sciences, Cryptogamie, Algologie, Cryptogamie, Bryologie, and Cryptogamie, Mycologie, also plan to use this model for future issues.

President's Message: *BioOne Leadership in 2013*

For the first time in many years, BioOne's Board of Directors mustered outside Washington, DC for its fall meeting. On November 30, 2012, the Marine Biological Laboratory (MBL) in Woods Hole, Massachusetts, hosted a suitably regal event. Whereas one might question the choice of Cape Cod at such a time of year, the weather cooperated and we were able to celebrate the service of outgoing director Catherine Norton (immediate past director of the MBL). As a member of the Executive Committee of the BioOne Board since 2007, Cathy provided valuable strategic insight, especially useful during the development of *Elementa: Science of the Anthropocene*. We are greatly indebted to Cathy's solid support, candid observations, and sense of humor throughout her tenure.

The Board also accepted the resignation of Stephen Howell (CFAO, The Nature Conservancy), with appreciation for his many contributions. As Chair of the Audit Committee since 2010, Steve played a critical role in the organization's financial oversight, and provided a welcome perspective from an allied, but much larger not-for-profit organization.

Since BioOne's incorporation, the Board has been guided by the wisdom of no fewer than 33 leaders from the scholarly communications and bioscience communities, including individuals who have worn more than one hat as publishers, library deans, university provosts, senior academic scholars, scientific society executive directors, consortial directors, journal editors, and members of the business community.



While visiting the Marine Biological Library at the Woods Hole Oceanographic Institute, the BioOne Board was allowed to peruse some of the library's treasures. One of the highlights of the collection is Conrad Gessner's 1560 edition of Nomenclator aquatilium

I am pleased to announce the 2013 election of Jeffrey L. Horrell, Dean of Libraries and Librarian of the College at Dartmouth. Jeff's role on the Board will include serving on the newly chartered Elementa Oversight Committee, which assists the Board in fulfilling its responsibilities to safeguard the corporation and its assets by monitoring the performance of the *Elementa* program.
