2019 Impact Factors and Subject Category Rankings Now Available

BioOne is pleased to share that 75% of eligible journals in BioOne Complete are ranked in this year's Journal Citation Reports® (JCR), and on average our journals' Impact Factor increased by 5%. All JCR information was compiled using Web of Science™ data from 2019.

JCR provides Journal Impact Factors and subject category rankings for indexed titles, among other statistics, and is widely used by both publishers and librarians to assist in title benchmarking and analysis.

BioOne Complete shows an impressive category concentration in many of our core fields, including:

- **Ornithology** — 10 out of the 28 ranked titles in JCR (36%)
- **Entomology** — 24 out of the 101 ranked titles in JCR (24%)
- **Biodiversity Conservation** — 13 out of the 59 ranked titles in JCR (22%)
- **Paleontology** — 12 out of the 55 ranked titles in JCR (22%)
- **Zoology** — 33 out of the 168 ranked titles in JCR (20%)
- **Ecology** — 26 out of the 168 ranked titles in JCR (15%)
- **Plant Sciences** — 30 out of the 234 ranked titles in JCR (13%)

BioOne is pleased to recognize these individuals for their clarity and creativity. Winners from each publication receive a \$1,000 award and wide dissemination of their research.

Our Ambassadors published on topics of groundbreaking research in zoology, including what happens to sleep-deprived tortoises and the value of 12-foot crocodiles lurking in museum collections. In marine science, we learned about the effects of water temperature on the glue that binds mussels to their ropes. And our ornithologist Ambassadors published their findings on the challenges for seabirds that breed in the world's driest desert and the best time to flood wetlands to support bird migration.



This year's winners were chosen through a competitive process. Active BioOne publishers were invited in January to nominate an early career researcher who published an article in their journal during 2019. To qualify, the author must be either a graduate student or a scientist who has completed their Ph.D. within the last five years. BioOne invited qualified nominees to submit a 250-word, plain-language summary explaining how the results of their work apply across disciplines and to the public at large.


